FINAL ORDER OF DISMISSAL

During her scheduled hearing on September 24, 2019, the Petitioner, Felicia McDade, decided to withdraw her Petition for Hearing, claiming that she would pursue other avenues to resolve her situation, including attempting to change the law that provides that a default into remaining in the Pension Plan, when the Florida Retirement System Investment Plan began in 2002, was an initial plan choice election. In response, the Presiding Officer entered a Recommended Order of Dismissal, which is attached as Exhibit A. The matter is now pending before the Chief of Defined Contribution Programs for final agency action.

ORDERED

This Final Order of Dismissal is entered, based on Petitioner's voluntary withdrawal of her Petition for Hearing that initiated the case.

Any party to this proceeding has the right to seek judicial review of the Final Order pursuant to Section 120.68, Florida Statutes, by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the State

Board of Administration in the Office of the General Counsel, State Board of Administration, 1801 Hermitage Boulevard, Suite 100, Tallahassee, Florida, 32308, and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within thirty (30) days from the date the Final Order is filed with the Clerk of the State Board of Administration.

RECOMMENDED ORDER OF DISMISSAL

At the scheduled hearing on September 24, 2019, Petitioner Felicia McDade stated that she had reviewed the Respondent's Exhibits R1-6, which were admitted into evidence without objection. After reviewing those exhibits, she decided to withdraw her Petition for Hearing filed August 15, 2019. She still asserts that her default into remaining in the Pension Plan, when the Florida Retirement System (FRS) Investment Plan began in 2002, was not an initial election, and that her later election into the Investment Plan was a first and not a second election and therefore permissible. But Petitioner determined that she will follow other avenues to dispute and attempt to change the law governing this issue.

I therefore recommend that the State Board of Administration enter a final order dismissing the petition in this case.


