FINAL ORDER



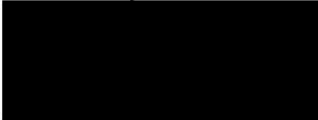


